- to have conducted a strategic market merger
- to have displayed persistence and determination in pursuing a set objective
- to have conducted a project that is unrivalled among its competitors
- to have made new technologies available to a wide range of recipients
- to have demonstrated the effectiveness of the actions they have undertaken
- to have consistently pursued set goals

### SOCIAL ENGAGEMENT

Those qualifying for this category should be using their capital, knowledge and social position as well as their participation in economic, political and cultural life to run social and charity activities, in particular they should:

- be actively participating in person, or through capital, in conducting charity and educational activities
- be effectively promoting concepts and solutions that improve the life of society
- be engaged in fighting social taboos in order to improve the standards and quality of life in society (e.g. educational initiatives)
- be running projects that support the development of local communities

## VISION AND INNOVATION

Those qualifying for this category should distinguish themselves by applying bold, new and unconventional business ideas, in particular they should:

- effectively and consistently promote their own business visions in the face of market scepticism
- market innovative solutions, services and products with the potential to make a positive impact in securing a company's position among its competitors
- demonstrate courage in making effective but non-standard business decisions that have an enduring, positive impact on the operations and development of companies
- display the ability and determination to overcome crises
